

The Great Escape - Terms & Conditions

Promoter

- The promoter is Ingenia Communities Group of Suite 1, 257 Gympie Road, Kedron QLD 4031 (ACN 46 154 464 990).

Eligibility

- To be eligible to enter you must be an Australian citizen and reside in either Queensland, New South Wales or Victoria. The location eligibility will be based on the postcode provided at the time of entry.
- To be eligible to enter you must be within the age brackets available on the entry form, being aged 50 years and or over.
- Employees, immediate family members of employees and employees of any company associated with the promotion are ineligible to enter.
